FACES OF HUNGER WAS A SHORT FILM CONTEST FOR YOUNG FILMMAKERS TO RAISE AWARENESS ABOUT HUNGER IN THE US AFFECTING MORE THAN 49 MILLION PEOPLE IN 2008. PALMS FOR LIFE ORGANISED THE CONTEST AND REACHED OUT TO HUNDREDS OF ORGANIZATIONS AND YOUNG FILMMAKERS INVITING THEM TO PARTICIPATE.
